## MEMORANDUM OF UNDERESTANDING ON

#### **Background**

#### **Purpose**

The purpose of this MoU includes, but is not limited to the following:

- \. To promote the exchange of postgraduate students and academic staff and render mutual assistance in upgrading their scientific qualifications;
- 7. To share experiences in facilitating teaching methods.
- <sup>r</sup>. To develop joint ventures between the two universities to provide internship study tours and summer sessions for students and visiting scholars.
- <sup>£</sup>. To collaborate in holding joint academic and scientific activities, such as postgraduate programs, courses, conferences, seminars, exhibitions, symposia, lectures, sports competitions, etc.;
- •. To inform each other of significant, relevant events, efforts, and activities and encourage and promote exchanges of information on all levels of interest;
- 7. To support the establishment of the chair of the languages and literature in both universities.

#### Agreement

Arrangements for scientific visits and other forms of cooperation will be developed according to the needs and resources and based upon rules and regulations of the two universities. All financial arrangements will be negotiated on a case by case basis and will depend upon availability of funds.

The terms on specific areas of cooperation shall be arranged upon in written form by both parties prior to the initiation of any particular activity. Specific details will be set forth in a letter of agreement which will include such items as the number of participants, elaboration of the responsibilities of each institution for the agreed upon activity, schedules, management, financial arrangements, etc.

Letters of agreement will be approved by both parties according to their procedures.
